

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-18.1, ONE WAY STREETS DESIGNATED, SUBSECTION 7-7.3, TEMPORARY PARKING PROHIBITED FOR SNOW PLOWING AND REMOVAL, SUBSECTION 7-11, PARKING TIME LIMITED ON CERTAIN STREETS DURING CERTAIN HOURS, SUBSECTION 7-12, PARKING PROHIBITED FOR STREET CLEANING AND MAINTENANCE, SUBSECTION 7-13, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS, SUBSECTION 7-14.1c, NIGHT PARKING RESTRICTED, SUBSECTION 7-14.7, ALTERNATE SIDE PARKING AND SUBSECTION 7-25, LOADING ZONES, OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE**

**BE IT ORDAINED**, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-18.1, One Way Streets, of the Revised General Ordinances of Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Section 2. Subsection 7-7.3, Temporary Parking Prohibited for Snow Plowing and Removal, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Section 8. Subsection 7-25, Loading Zones, of the Revised General Ordinances of the Township of West Orange, Orange is hereby supplemented and amended as follows: *(italic type denotes deletion, bold type denotes addition):*

<b>Ashland Avenue</b>	<b>All</b>	<b>West</b>	<b>Beginning 105 feet south of the southerly curbline of Lakeside Avenue extended and extending 151 feet southerly.</b>

Section 9. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications

of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of this Ordinance are severable.

Section 10. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 11. This Ordinance shall take effect upon final passage and publication in accordance with law.

### **LEGISLATIVE HISTORY**

Ashland Avenue, between Lakeside Avenue and Park Avenue has historically been a Two-Way traffic street with Alternate Side Parking adjoining the residential portion from Park Avenue to Charles Street, and a mix of No Parking and Loading Zones adjacent to the old Edison factory. Upon creation of the Edison Lofts development, these parking regulations are now outdated. Parking on both sides of the street is needed to meet the parking demand. To affectively allow parking on both sides the two-way traffic flow must be eliminated to avoid congestion.

To eliminate this hazard, the Township Engineer and the West Orange Police Department Traffic Division propose changing Ashland Avenue between Lakeside Avenue and Park Avenue to a one-way street flowing northbound. This will eliminate traffic congestion in the neighborhood, and allow street parking on both sides, except for street cleaning, snow control and a loading area at the entrance to the Edison Lofts. These ordinance amendments will allow these changes to be implemented and the one way and parking regulations will be consistent with the block of Ashland Avenue from White Street north to Park Avenue. This too is one way northbound with parking permitted on both sides except for street cleaning and snow control.
