

AMENDED RESOLUTION

WHEREAS, the Township of West Orange Housing Rehabilitation Program has a mortgage against certain real property owned by Christopher Baker (the “Owner”) residing at 17 Phyllis Road, Block 154.05, Lot 11 (the “Property”), in the amount of Fourteen Thousand Nine Hundred Ninety-Five Dollars (\$14,995.00), which was dated May 5, 2007 and recorded in the Essex County Register’s Office on August 1, 2008 in Book 12150, Page 7342 (the “WOHRP Mortgage”); and

WHEREAS, there is a first mortgage on the Property held by Nationstar/Mr. Cooper in the outstanding amount of One Hundred Sixty Thousand, Nine Hundred Nine Dollars and Eighty-Two Cents (\$160,909.82) (the “First Mortgage”) at an interest rate of 6.644%; and

WHEREAS, the Owners desire to refinance their home to obtain a new mortgage loan from Mortgage Electronic Registration Systems, Inc. as nominee for Quicken Loans, LLC (“Quicken”) in the amount of One Hundred Seventy Thousand, Three Hundred Dollars (\$170,300.00), and with an interest rate of 3.625% (the “New Mortgage”); and

WHEREAS, the New Mortgage will pay off the First Mortgage; and

WHEREAS, the Owners have requested that the Township of West Orange subordinate the WOHRP Mortgage to the New Mortgage; and

WHEREAS, the appraised value of the property is \$391,000; and

WHEREAS, based on the amount of the New Mortgage as compared to the First Mortgage, the proposed subordination will not materially change the equity available to satisfy the WOHRP Mortgage;

WHEREAS, on February 9, 2021, the Township adopted Resolution 34-21 which authorized the execution of the Subordination of Mortgage, annexed hereto as Exhibit “A;” and

WHEREAS, Resolution 34-21 identified the New Mortgage lender as “Quicken Loans, Inc.” rather than “Mortgage Electronic Registration Systems, Inc. as nominee for Quicken Loans, LLC;” and

WHEREAS, pursuant to Resolution 34-21, the Subordination of Mortgage was executed and forwarded to Quicken; and

WHEREAS, Quicken has requested that Resolution 34-21 be amended to reflect its name as “Mortgage Electronic Registration Systems, Inc. as nominee for Quicken Loans, LLC” consistent with the previously authorized Subordination of Mortgage, annexed hereto as Exhibit “A.”

NOW THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, that Resolution 34-21 be amended to identify Quicken as “Mortgage Electronic Registration Systems, Inc. as nominee for Quicken Loans, LLC;” and be it further

RESOLVED, that the Subordination of Mortgage previously executed pursuant to Resolution 34-21 shall remain unchanged and shall remain authorized; and be it further

RESOLVED, that a copy of this Resolution shall be made available in the Clerk’s office in accordance with applicable law.
