

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7, TRAFFIC, SUBSECTION 7-18.1, ONE WAY STREETS DESIGNATED, SUBSECTION 7-7.3, TEMPORARY PARKING PROHIBITED FOR SNOW PLOWING AND REMOVAL, SUBSECTION 7-12, PARKING PROHIBITED FOR STREET CLEANING AND MAINTENANCE, SUBSECTION 7-14.1c, NIGHT PARKING RESTRICTED AND SUBSECTION 7-14.7, ALTERNATE SIDE PARKING OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF WEST ORANGE

BE IT ORDAINED, by the Township Council of the Township of West Orange, in the County of Essex, State of New Jersey as follows:

Section 1. Subsection 7-18.1, One Way Streets, of the Revised General Ordinances of Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Direction	Limits
Dean Street	North	Joyce Street to Valley Road

Section 2. Subsection 7-7.3, Temporary Parking Prohibited for Snow Plowing and Removal, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Side	Limits
Dean Street	West	Joyce Street to Valley Road

Section 3. Subsection 7-12, Parking Prohibited for Street Cleaning and Maintenance, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Side	Hours and Days	Location
Dean Street	East	Thursday 9 A.M. to 1P.M.	Joyce Street to Valley Road
Dean Street	West	Monday 9 A.M. to 1P.M.	Joyce Street to Valley Road

Section 4. Subsection 7-14.1c, Night Parking Restricted, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Exceptions:

Name of Street	Sides	Location
Dean Street	Both	Joyce Street to Valley Road

Section 5. Subsection 7-14.7, Alternate Side Parking, of the Revised General Ordinances of the Township of West Orange is hereby supplemented and amended as follows: (*italic type denotes deletion, bold type denotes addition*):

Name of Street	Column A	Column B	Location
<i>Dean Street</i>	<i>West</i>	<i>East</i>	<i>Entire length</i>

Section 6. If any provisions of this Ordinance or application thereof, under any circumstances, is held invalid, the invalidity shall not affect any of the provisions or applications of this Ordinance that can be given effect without the valid provision(s) or application and to this end, the provisions of this Ordinance are severable.

Section 7. All other Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed.

Section 8. This Ordinance shall take effect upon final passage and publication in accordance with law.

LEGISLATIVE HISTORY

Dean Street, located in the Valley between Joyce Street and Valley Road and one block west of Lafayette Street which is a one way street southbound immediately east of Dean Street along the border with the City of Orange Township, has a disproportionately higher volume of traffic than Lafayette Street since it is a two way street. This Ordinance will designate Dean Street a one way street northbound opposite that of Lafayette Street, to balance the volume flow of traffic between the two streets. This Ordinance will allow parking at all times on both sides of Dean Street except for two four hour periods for street cleaning and maintenance. Thus, the alternate side regulations will be repealed. However, overnight parking will be allowed as Dean Street will still be an exception to the No Parking 2 A.M. to 5 A.M. regulation.
