

**RESOLUTION OF THE WEST ORANGE TOWNSHIP ABC BOARD**

**RESOLUTION RESCINDING IN PART ABC RESOLUTION NO. 669-21, REMOVING LICENSEE # 0722-33-021-004, 4 CORNERS DELI, LLC (POCKET LICENSE) AS A LICENSE APPROVED FOR RENEWAL FOR THE 2021-2022 LICENSE TERM FOR FAILURE TO MEET ALL QUALIFICATIONS FOR RENEWAL FOR THAT TERM**

**WHEREAS**, in July of 2021, the Clerk of the West Orange ABC Board, believing that NJ ABC License #0722-33-021-004, for Licensee 4 Corners Deli, LLC, was qualified for renewal of said License for the 2021-2022 License Term; and

**WHEREAS**, that Licensee was included with others on West Orange Township ABC Board Resolution No. 669-21, renewing for the 2021-2022 License Term those Licensees named therein; and

**WHEREAS**, the Clerk having been notified recently by the New Jersey Attorney General's Office on behalf of the State Division of Alcoholic Beverage Control and its Licensing Bureau of that Licensee's failure in fact to meet all the qualifications for renewal for that License Term and other defects with respect to that License also needing correction; and

**WHEREAS**, the State ABC Agency has further advised the Clerk of the individual steps needed to be taken to attain renewal of that License for the 2021-2022 License term and the separate amendments, approvals and petitions necessary for other and future renewals of that License and to avoid its permanent lapse; and

**WHEREAS**, the first required step to be met by the Township of West Orange is the rescission of Township ABC Board Resolution No. 669-21, only with respect to the License 0722-33-021-004, Licensee 4 Corners Deli, LLC, t/a Don Juan Restaurant, a pocket license;

**NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, SITTING IN ITS CAPACITY AS THE WEST ORANGE TOWNSHIP ABC BOARD**, that the portion of West Orange Township ABC Resolution No. 669-21, listing License #0722-33-021-004, 4 Corners Deli, LLC, (pocket license), as one among other ABC Licenses to be renewed for the 2021-2022 License term, is to that extent and that extent only, hereby rescinded, excising that License from the list of those which were to be renewed for that License term, all in accordance with instructions received by and on behalf of the New Jersey ABC Licensing Bureau.
