

RESOLUTION OF THE WEST ORANGE TOWNSHIP ABC BOARD

**RESOLUTION REAPPROVING RENEWAL OF THE
ABC LICENSE FOR SHAKU & KAAMIL, INC.,
LICENSE #0722-44-061-008 , NUNC PRO TUNC FOR
THE 2018-2019 LICENSE TERM EFFECTIVE
JULY 30, 2019, THE DATE ON WHICH THE
LICENSEE'S 12.18 AND 12.39 SPECIAL RULINGS
WERE GRANTED BY THE STATE ABC DIVISION.**

WHEREAS, Shaku & Kaamil, Inc., the holder of ABC License #0722-44-061-008, an inactive license, had made application for renewal of its license for the 2018-2019 license period, and the Clerk of the West Orange ABC Board then believing that the Licensee had paid the required License renewal fees and was thought to have met all the qualifications for renewal of its License; and

WHEREAS, a public hearing having been held before the West Orange ABC Board on July 17, 2018, no one appearing in opposition to the License renewal, and the ABC Board in its normal course having adopted ABC Resolution #605-18, approving renewal of ABC License #0722-44-061-008, for the 2018-2019 license term; and

WHEREAS, it was later determined that said Licensee had not in fact met all of the necessary jurisdictional requirements for renewal, rendering the renewal ineffective; and

WHEREAS, the West Orange ABC Board on July 16, 2019, following the advice and instructions of the New Jersey Attorney General's Office on behalf of the State Division of Alcoholic Beverage Control, adopted ABC Resolution #630-19, rescinding in part ABC Resolution #605-18, rescinding and excising ABC License #0722-44-061-008, from the list of those Licenses renewed for the 2018-2019 License Term; and

WHEREAS, the State ABC Division has confirmed that the Special Rulings required for renewal of this License for the 2018-2019 and 2019-2020 License Terms were issued on July 30, 2019 for 12.39 relief pursuant to N.J.S.A. 33:1-12.39, and 12.18 relief pursuant to N.J.S.A. 33:1-12.18; and

WHEREAS, the Township has been advised by the NJ Division of Alcoholic Beverage Control of the need for this *nunc pro tunc* Resolution to properly complete its records and to effectuate formally the renewal of that ABC License for Shaku & Kaamil, Inc., for the 2018-2019 License Term, and as a pre-qualification for any renewals of that License thereafter;

NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, SITTING IN ITS CAPACITY AS THE WEST ORANGE TOWNSHIP ABC BOARD, that ABC License #0722-44-061-008, an inactive license held by Shaku & Kaamil, Inc., application having been

made, all fees due having been paid, all required advertisements having been published, and needed Special Rulings from the State of New Jersey Division of Alcoholic Beverage Control for 12.18 and 12.39 relief having been issued on July 30, 2019, all with respect to and for renewal of its license for the 2018-2019 License period, that License is and hereby is renewed *nunc pro tunc* for the 2018-2019 License Term effective July 30, 2019.
