

**RESOLUTION OF THE WEST ORANGE TOWNSHIP ABC BOARD**

**RESOLUTION RENEWING THE ABC LICENSE FOR  
SHAKU & KAAMIL, INC., LICENSE #0722-44-061-008  
NUNC PRO TUNC FOR THE 2019-2020 LICENSE TERM  
EFFECTIVE JULY 30, 2019, THE DATE ON WHICH THE  
LICENSEE'S 12.39 SPECIAL RULING WAS GRANTED  
BY THE STATE ABC DIVISION.**

**WHEREAS**, Shaku & Kaamil, Inc., the holder of ABC License #0722-44-061-008, an inactive license, had made application for renewal of its license for the 2019-2020 license period, had paid the required State fee and later received required Special Rulings from the State of New Jersey Division of Alcoholic Beverage Control; and

**WHEREAS**, a search of the records reflect an absence of evidence that the Township ABC Board adopted the required Resolution renewing License #0722-44-061-008, for the 2019-2020 License Term; and

**WHEREAS**, State ABC Division has confirmed that the Special Ruling required for renewal of this License for the 2019-2020 License Term was issued on July 30, 2019 for 12.39 relief pursuant to N.J.S.A. 33:1-12.39; and

**WHEREAS**, the Township has been advised by the NJ Division of Alcoholic Beverage Control of the need for this *nunc pro tunc* Resolution to remedy the defect in the records and to effectuate formally the renewal of that ABC License for Shaku & Kaamil, Inc., for the 2019-2020 License Term, and as a pre-qualification for any further and future renewals;

**NOW, THEREFORE, BE IT AND IT HEREBY IS RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WEST ORANGE, SITTING IN ITS CAPACITY AS THE WEST ORANGE TOWNSHIP ABC BOARD**, that ABC License #0722-44-061-008, an inactive license held by Shaku & Kaamil, Inc., application having been made, all fees due having been paid, all required advertisements having been published, and the needed Special Ruling from the State of New Jersey Division of Alcoholic Beverage Control for 12.39 relief having been issued on July 30, 2019, all with respect to and for renewal of its license for the 2019-2020 license period, that License is and hereby is renewed *nunc pro tunc* for the 2019-2020 License Term effective July 30, 2019.
